The Irish High Court has fixed 9:00 a.m. Eastern Time (in the U.S.) on September 16, 2019 as the record date for the determination of shareholders entitled to receive notice of and to attend, speak and vote at the Court Meeting of the Scheme Shareholders (as defined in the proposed scheme of arrangement referred to in the Notice convening the meeting to which this Form of Proxy relates) convened by order of the Irish High Court pursuant to Section 450(3) of the Companies Act 2014 (the "Court Meeting"). Only shareholders of record at 9:00 a.m. Eastern Time (in the U.S.) on September 16, 2019 will be entitled to receive notice of and to attend, speak and vote at the Court Meeting or any adjournment thereof. Your attention is directed to the proxy statement for more complete information regarding the matters to be acted upon at the Court Meeting.

You may vote the shares in person at the Court Meeting. A proxy need not be a shareholder of record.
