Indications

- For the temporary relief of burning, irritation, and discomfort due to dryness of the eye or exposure to wind or sun.
- May be used as a protectant against further irritation.

Directions

Place 1 or 2 drops in the affected eye(s) as needed.

Precautions

- Do not use if allergic to any of the ingredients
- Do not swallow solution
- To avoid contamination, do not touch bottle tip on any surface, and avoid direct contact with the eye
- Close the bottle tightly immediately after use
- Do not use after expiry date marked on the product
- Keep out of the reach of children
- Do not use the bottle if the tamper-proof seal on the bottle neck is broken before you first use it
- Allow 5 minutes between the administrations of ophthalmic products

Side effects

The following side effects may occur:

Eyes stinging, burning, irritation or itching, excessive tearing, unusual eye secretions, eye redness, reduced sharpness of vision, blurred vision, sensitivity to light and dry eyes (lack of effect).
